Item 1 Approval of Agenda

The agenda was approved as distributed.

Item 2 Approval of Minutes

The approval of the Minutes of the 581st meeting of Senate was postponed to the January 2017 meeting.

Item 3 Communications from the Chair

Negotiations around funding

Discussions with government officials to find a permanent solution to Bishop's funding challenges were progressing well. The Principal stressed the importance of Bishop's meeting its commitments made in the recovery plan submitted to the Ministry.

Civic Leadership Institute at Bishop's

On December 12th 2016, the Premier announced a Civic Leadership Institute for Anglophone Youth, part of a broader youth leadership initiative. Thanks to the efforts of Dean of Education and Associate Vice-Principal Continuing Education Marie-Josée Berger, Bishop's had received funding and support to lead the Institute.

Strategic Infrastructure Fund for Post-Secondary Education

On December 16th 2016, Prime Minister Justin Trudeau and Quebec Premier Philippe Couillard announced \$1.1Bn in infrastructure funding for Quebec universities, including a new Science complex at the Université de Montréal. Additional announcements of infrastructure projects funded under the program would be made over the course of December and January.

In response to a question, Morgan Gagnon explained that the Philosophy of Sexuality Course had not been recommended because it had been offered two years running, and Psychology was planning to offer a course on a related topic. SPC had aimed for greater variety in order to increase the registrations in each course.

Item 5.2 Report of the Senate Timetable Committee on a Course Scheduling Policy

The Vice-Principal opened discussion by recalling that concerns had been raised during the discussion of this item at the 581st meeting of Senate:

- it might be difficult for some Departments to meet the requirement that 50% of classes be scheduled outside of the most popular time periods;
- the impact of changes to the Monday/Wednesday grid would create a significant preference for the Tuesday/Thursday time slots;
- the priority given to high-enrolment programs in the allocation of large classrooms might create an obstacle to growing enrolment in smaller Departments, making it more difficult for them to respond to the incentives of the Resource Allocation Model.

Dr. Nicole Riley, analyst in the Registrar's Office, addressed the drivers for the proposed changes to the timetable and the policy decisions of Senate Planning Committee: the need to use our space for a greater portion of each day and from Monday to Friday.

Senators thanked Dr. Riley for her presentation (appended to these minutes).

In response to questions, the Vice-Principal indicated that SPC had considered the impact of scheduling classes on Friday on opportunities for experiential learning and carrying out research, and had concluded that timetables could be organised to meet these needs.

The Vice-Principal moved the approval of the course scheduling policy as circulated to the 582nd meeting of Senate (Document 582/5.2), and Francine Turmel seconded the motion.

The motion carried, one opposed, one abstention.

Item 5.3 Report of Academic Standing and Admissions Policy Committee on guidelines for course outlines

The Registrar presented guidelines for course outlines and asked for Senate endorsement of the guidelines. Lauren Audas moved that Senate endorse the document, and Tayler Ross seconded the motion.

The motion carried.

Item 5.4 Name change Committee on Student Accessibility Accommodation Services

On behalf of the Committee on Students with Disabilities, Morgan Gagnon moved that Senate approve a change in the committee's name, to the Committee on Student Accessibility and Accommodation Services. Jenn Cianca seconded the motion.
