1/396 APPROVAL OF THE AGENDA

It was moved by Dr. Norman, seconded by Dr. Forrest, that the agenda be approved as presented.

Motion carried.

2/396 MINUTES

Dr. Yeats indicated that the minutes of the 395th meeting appeared to be incomplete; it was agreed that the Secretary would follow up, and that the minutes would be presented for approval at the first meeting in the fall.

3/396 COMMUNICATIONS FROM THE CHAIR

Dr. Cook reminded Senators that the Business Meeting of Convocation would follow directly after today's Senate meeting, and that a special meeting of Senate had been called for Tuesday 20 May, at 9:00 a.m.

4/396 BUSINESS ARISING

a) 1/391/b: Technical Information Committee. Dr. Cook referred to a document circulated by Mr. André Rodrigue concerning the technological requirements of a variety of types of university extension courses, and invited Senators to discuss these with

Mr. Rodrigue if they wished.

5/396 COMMITTEE ITEMS

- I) 5/392/I: Dean's follow-up on SPARC report for Geography. Prof. Siddiqui indicated that this had already been presented to Senate. Dr. Cook undertook to locate and circulate the report.
- ii) 5/395/iii: Dr. Forrest indicated that the proposal for a combined English Writing Proficiency and English Language Committee would come forward in the fall.
- iii) Senate Nominating Committee: Mr. Curran referred to the requirement that two faculty members be elected "at large" for the newly-revised Student Appeals Committee. It was pointed out that, although further modifications to the mandate and membership of this committee were to come forward in the fall, some provision was needed in the event it had to meet during the summer. After some discussion, it was moved by Dr. Forrest, seconded by Dr. Stritch, that, pending the approval of Dr. Lin, Dr. Taseen and Dr. Lin continue to serve on the Student Appeals Committee for the summer months.

- iv) 5/395/v: Mr. Curran advised Senate that he estimated the library costs to start up the recently approved new programmes would be in the area of \$8,000, or about 1.5% of the total acquisitions budget. This amount would not necessarily be distributed evenly between the new programmes, given their differing needs.
- v) 5/395/vii: Teaching Evaluations Committee. Dr. Taseen said this issue would be brought forward in the fall.
- vi) Dr. Cook reported that the SPARC review of Sociology and Anthropology had been deposited, along with the Department's comments. The SPARC Committee's summary of the recommendations, with suggestions for referral, will be tabled in the fall.
