## 5/411 COMMITTEE ITEMS

- i) SPARC
- a) Dr. Cook tabled the Chemistry Report. The Dean is to report back to Senate in one year on the recommendations made in the report.
- b) Dr. Johnson reported that the Department of Sociology and Anthropology had addressed reasonably the SPARC recommendations. Concern was expressed that there would be no follow-up until the next SPARC review. Discussion then focused mainly on recommendation #4 of the report.

- c) Dr. Johnson reported that the Department of Political Studies also addressed reasonably the SPARC recommendations except one which the Department would prefer to modify to group courses under five subfields.
- ii) Senate Planning Committee.
- a) Dr. Cook moved, seconded by Mr. Roy, that Senate approve the Senate Planning Committee's recommendations that the School of Education, the Williams School of Business and Economics, and the Department of Fine Arts be granted half-sessional appointments for the winter semester 1999 which would not exceed the first level of Assistant Professor.

b) The Chair read a letter from the APBU which expressed their concern with regard to recommendation 9. Dr. Cook deposited the report and said that it would be circulated for wide consultation which would start at the beginning of the year and would end in late January. He then clarified various points, for example, that the French FTE faculty should read 4.25 instead of 4.75, and that the Committee had used the Projected Academic Budget for 1999-2000 as a planning tool. After the Chair had thanked the Committee for their work, the members of the Committee answered questions.

## 6/411 OTHER MATTERS

i) 6/410/i - Notice of Motion - Course Coding. It was moved by Dr. Black, seconded by Dr. Johnson, that each course be assigned only a single identification code, and that all present courses with multiple designators revert to only a single such identifier.

ii) Dr. Cook presented a proposal with respect to courses given by Bishop's University outside Canada. It was moved by Dr. Cook, seconded by Dr. Forrest, that the two-step academic and administrative approval procedures as outlined in the proposal be followed each time any course is to be offered outside Quebec.

These courses being a redistribution of previous courses, Dr. Forrest said that he would clarify the wording of the course descriptions before they appear in the calendar.
