# MINUTES OF THE 418th MEETING OF SENATE

### 3/418 COMMUNICATIONS FROM THE CHAIR

Mrs. Hodder welcomed Senators to a new academic year, noting in particular the presence of new Senators Jonathan Rittenhouse, Adriana Murphy, Erin Leath, Sheila Curran, Kate Hughes, and Andrew Lacas.

She invited Senators to consider the possibility of changing to an afternoon meeting time, suggesting Wednesday at 4:30 p.m. as an option. It was moved by Dr. van Hulst, seconded by Ms. Murphy, that Senate approve in principle the notion of holding Senate meetings in the afternoon.

### Motion carried.

Mrs. Hodder indicated that Senate would continue to meet at 7:00 p.m. on Mondays for this semester, and that members would be consulted further before any decision was taken.

The Principal informed Senate that the position of Vice-Principal would not be filled immediately, and drew Senators' attention to a document indicating how Dr. Cook's responsibilities were to be divided among the Deans and other staff. She said that Faculty Council would be consulted soon about the search process for a new Vice-Principal, and that she hoped the position would be filled by July 2000 at the latest.

The Deputy Minister of Education, M. Jacques Babin, will visit Bishop's on Thursday, 23 September.

The administration is in the process of preparing a proposal for submission to the Ministry, in response to an indication that the government may be ready to re-invest in post-secondary education. Though it is not yet certain to what extent this investment will happen, it at least seems sure that the period of drastic budget cuts has ended.

Mrs. Hodder noted that enrollment for Fall 1999 is likely to exceed 1900, and that some 20% of the incoming class are scholarship students.

In response to a question from Dr. McLean, Mrs. Hodder said that the Vice-Principal's position on the Senate Planning Committee will remain vacant for the present, unless the SPC indicates the need for a replacement.

With regard to the procedural rules for Senate meetings, it was agreed that in general meetings would not last longer than two hours, that Robert's Rules of Order would continue to be followed (with some allowance for flexibility in particular situations), and that the most important items would be placed first on meeting agendas. Mrs. Hodder asked that documents for Senate be submitted to the Secretary one week before the meeting, and in electronic format (diskette or e-mail) if at all possible.

## ii) 6/416 Status of new programmes

The Registrar reminded Senators that the process of establishing academic programmes in disciplines which are new to the institution includes obtaining approval from CREPUQ as well as from the Ministry of Education. Funding of students enrolled in these programmes depends on their being recognized by the Ministry. However, the "new" programmes which were adopted by Senate over the last two years do not easily fall into categories recognized by these approval bodies, as they consist almost entirely of courses already in the curriculum and require no additional personnel or other resources.

At a meeting held recently with representatives of the Ministry of Education, it was suggested that several of these programmes could be regarded as "themes" or concentrations within existing programmes, and thereby avoid the cumbersome approval process. Neuroscience, Gerontology, and Psychology and Human Resource Management would thus be seen as options within the B.A. programme in Psychology.

Women's Studies, Arts Administration, and the Science Teaching major could perhaps be listed as options within the Divisional Majors, or, in the case of Arts Administration, as an option within the B.A. Business programme. The Registrar invited the Divisions to consider how they would like these programmes to be described.

The Ministry has agreed that Liberal Arts is essentially a re-working of the Divisional Major in Humanities, and the change of name has been accepted.

The Registrar will circulate to Senators the relevant legislation and CREPUQ new programme approval guidelines.

#### 5/418 COMMITTEE ITEMS

i) Research Committee.

a) Mandate revision: Dr. Rittenhouse asked that this item be withdrawn. In passing, he noted that a resolution dealing with the various Ethics Committees would come forward to Senate at its next meeting.

5/418 b) Year-end Report 1998-99. Dr. Tom Gordon, Chair of the Senate Research Committee, drew Senate's attention to the main issues in his report. He indicated that the Research Directory was now up on the Bishop's web site, and that it was being updated with this year's information. The new guidelines for grants which were approved last year appear to be working well. There has been an augmentation in funds available to the Committee, both from SSHRC and as a result of the Bandeen fund having been capitalized. Grant applications are showing a considerable increase in the research training component.

Dr. Gordon regretted that the absence of a Research Officer had meant no Bishop's participation in the Canadian Foundation for Innovation grants, and underlined his Committee's concern that other funding opportunities, especially for junior faculty, are being missed.

It was moved by Dr. L-G. Harvey, seconded by Dr. Crooks, <u>that Senate endorse the</u> recommendation of the Senate Research Committee that the position of Research Officer <u>be created as soon as possible</u>, with the terms and responsibilities outlined in the SRC's <u>1998-99 Year-end Report</u>.

# Motion carried.

ii) Nominating Committee

It was moved by Dr. Stritch, seconded by Dr. Rittenhouse, <u>that Ms. Adriana Murphy, Mr.</u> <u>Ed Flavelle, and Dr. Ken McLean be elected to fill vacant positions on the Nominating</u> <u>Committee for 1999-2000.</u>

# Motion carried.

Dr. Stritch indicated that the Committee will be canvassing faculty over the next few weeks for nominations to fill vacancies on Senate committees. He expected that a report would be brought to the next Senate meeting, and asked that in the meantime committees continue to operate with their current membership.

It was moved by Prof. Siddiqui, seconded by Dr. L-G. Harvey, <u>that the Timetable</u> <u>Committee be eliminated</u>.

# Motion carried.

### iii) Senate Planning Committee

It was moved by Dr. L-G. Harvey, seconded by Ms. Murphy, given the favourable enrollment statistics for Fall 1999 and the indication of increased funding from the Provincial Government, <u>that the one-year positions in Business</u>, <u>Computer Science</u>, <u>Geography</u>, <u>History</u>, and <u>Mathematics approved by the Senate Planning Committee</u>, <u>Senate and Corporation for the academic year 1999-2000</u>, with a provision for their <u>conversion to tenure-stream upon review</u>, <u>be immediately converted to tenure-stream</u>, and <u>that the departments concerned be permitted to advertise these positions immediately</u>.

### Motion carried.

Mrs. Hodder undertook to bring this resolution forward to the Executive Committee at its meeting on September 24th.
