BISHOP'S UNIVERSITY MINUTES OF THE 425th MEETING OF SENATE

3/425 COMMUNICATIONS FROM THE CHAIR

Mrs. Hodder reported that a meeting had taken place between the Executive Committee of CREPUQ and the Minister of Education. It appears that some elements of the original funding plan are being revised, and that the impact of the new funding rules is likely to be positive for Bishop's. The university heads requested that the Ministry consider three-year funding guarantees in return for three-year forward planning.

There has been some discussion of the ways in which "performance contracts" could be

elaborated: one idea is to do a benchmarking exercise with institutions of similar size and character, in Bishop's case perhaps one or two of the maritime universities.

A proposal for the 2000-01 operating budget is to be submitted to the Finance and Executive Committees for approval in June. It is still expected that we will see a deficit of \$400,000.

The Principal noted that Bishop's is eligible for a Millenium Chair, on condition that an institutional research plan is prepared and submitted by August.

4. <u>BUSINESS ARISING</u>

5. <u>COMMITTEE ITEMS</u>

a) Animal Care Committee.

Dr. Drumheller proposed an amendment to the terms of reference of the Animal Care Committee, to clarify the position of Honours research projects with regard to the need for external review of proposals. She moved, seconded by Dr. Crooks, <u>that the following</u> <u>text be added to section 3(d) of the Terms of Reference:</u>

Since the primary aim of Honours research projects is educational, such projects need not be subject to external review. However, the committee reserves the right to request that such a review be undertaken.

b) Senate Planning Committee.

Dr. Clark-Jones brought forward recommendations from Senate Planning with regard to replacements for full-time faculty who are retiring, going on leave, or moving to administrative positions.

ii) The Senate endorsed a recommendation from the Search Committee for Vice-Principal that Dr. Jonathan Rittenhouse be offered the appointment, under the terms set out by the Rules, Orders and Regulations of the University, subject to final approval by the Corporation.

iii) Mrs. Hodder informed Senate that Dr. Curt Rose had accepted the position of Ombudsman for a two-year term effective 1 July 2000.
