  - c) Dr. J. Manore presented the Report of the Senate Library Committee 2004-2005. The allocation formula for Periodicals and Monographs has caused problems in the past because the periodicals have gone up in price compared to monographs.

# iv) Art Gallery Update:

Dean S. Sheeran informed Senate that there had been a meeting of the newly constituted Art Gallery Committee in July, 2005 following the submission of the first Art Gallery Strategic Plan. Interesting discussions had arisen which had served to isolate some problem areas. A fuller report will be made at a future Senate Meeting. However, in the course of the first meeting the status of the Art Gallery Committee had been raised, and Dean Sheeran wished to confirm for the record that this is to be an Advisory Committee, the purpose of which is to provide broader input to the Dean and to the Art Gallery staff in the managing of the Art Gallery.

# v) Centennial Theater Update:

Dean S. Sheeran informed Senators that the various sources of funding for the Centennial Theatre renovations had been falling into place, and the theatre is scheduled to close for the Winter Semester (from January to mid-March) to allow for these renovations. Final confirmation of the Provincial Government's share in the project (\$750,000) is pending.

vi) Breadth Requirement for a « sound and Liberal Education :

The Dean of the Division of Natural Sciences and Mathematics presented the wishes of the Division to have a minimal achievement scientific and mathematical numeracy as a positive outcome that all Bishop's graduates be required to take certain science and math courses.

Dr. G. Wickens said he was opposed to the proposal on the grounds of forcing students to take a structured program. Dean A. Johnson said he would bring this item to his division for discussion. Dean S. Sheeran said the same. Mr. Ialenti, President of the SRC agreed in principle, but thought it was hard to put in practice, particularly for CEGEP students. Other members mentioned that their programs already had mathematical contents in their programme.

Standing was in accordance with Dean Johnson's position. Mr. A. Lachambre replied that some professors who don't have a Masters Degree were some of the best professors. Prof. J. Manore and Dean S. Sheeran believed that he had the necessary qualifications. Dean S. Sheeran added that in Fine Arts and Music it was hard to find candidates in these practical areas with graduate degrees, and that experience was an important factor to consider.
