1/495 AGENDA

3/495 COMMUNICATIONS FROM THE CHAIR

Vice-Principal Rittenhouse reported the Principal, Dr. Poupart, was away continuing his work with the Strategic Plan financial negotiations with the government. He also spoke about the Canadian Government release of its policy on "Mobilizing Science and Technology" earlier in the day.

4/495 BUSINESS ARISING

i) 1/494 Strategic Planning

It was moved (Béquet/Willms) that Senate supports in principle the direction of the Strategic Plan and authorizes the Principal to continue discussion with MELS (Ministère de l'Éducation, du Sport et des Loisirs).

Issues and concerns discussed by Senators were about supporting the direction of the plan, continuing discussion with government, the level of buy-in of the Bishop's community and the conditions of governmental extra funding.

- ii) Academic Structures Committee Report

The Vice-Principal indicated the May 11th document had been circulated for information. A second version, dated May 12th, was now a more recent version of the report. The Chair of the School of Education wanted the record show that the report in no way responded the request of the School of Education made and it continued the ambiguity of the School of Education position within the University. The School of Education wants equal status with the other Divisions of the University and not with the status of the head of the School of Education.

iii) Senate Nominating Committee Report

Prof. R. Brown presented his report.

It was moved (Brown/Béquet) that Senate approve the addition of a School of Education representative on the Teaching Evaluation Committee. **Motion**Carried

In order to fill the Senate Nominating Committee, it was moved (Brown/Teasdale) that Senate approve the appointment of Dr, V. Faraoni

(Natural Sciences) and Dr. L. Zubieta (Business) for two-year terms and Mr. A. Martinez (Full Time Student) for the 2007/2008 academic year. **Motion Carried**

It was moved (Brown/Sheeran) that Senate receive the updated Senate Committee list for 2007/2008. **Motion Carried**

iv) Committee on Prizes and Scholarships

The Registrar reported verbally on the meeting Committee on Prizes and Scholarships held earlier in the day, a printed version to follow.

6/495 OTHER MATTERS

At this point Dr. L. Standing took over the Chair so that the Vice-Principal could present his report.

i) Report from the Vice-Principal

Following Senate's creation of a Task Force on Recruitment and Retention and the Task Force recommendations to Finance Committee, and the visit of the Executive Director of the Canadian Association for Community-Service Learning. Also further to the Strategic Plan's recommendations concerning academic programs and the necessity for the University to increase its enrollment through the offerings of attractive programs, the Vice-Principal brought in three recommendations for Senate's approval.

Some concerns were raised by the existing number of committees at Bishop's. Some redundant committees already in existence might need to be dismantled.

It was moved (Béquet/Molyneux) that Senate officially approve the establishment of the Working Group on Experiential Learning with the Vice-Principal as Chair and that it make reports and recommendations to Senate or Student Services, as appropriate, and that such a working group have representation from faculty, students and staff. In particular such a working group should also make recommendations as to the creation of a Centre for Learning and Teaching. **Motion Carried**

It was moved (Rittenhouse/Willms) that Senate create the new Internal Program Review and Development Committee and that it be composed of the Heads of each School or Division or a faculty member so designated by the head, a student and a representative from Student Services. The Vice-Principal would be non-voting Chair. That it be convened as soon as possible. That its mandate be to review existing programs and to receive and review proposals for new programs in light of an approved Strategic Plan and make recommendations to departments, programs, divisions/schools or Senate, as necessary. That it ensure the proper submission of any new program dossier to the CREPUQ committee overseeing new program approvals. **Motion Carried**

It was moved (Rittenhouse/Sheeran) that Senate create the Committee on Graduate Studies and that it be composed of representatives from each division/school, a graduate student and a Senior Academic Officer (who shall chair) and that Senate Nominating Committee fill the committee as soon as possible. That its mandate be to assess and review all proposals for Graduate Programs and that it make recommendations to departments, programs, divisions/schools or Senate, as necessary. That it ensure the proper submission of any new program dossier to the CREPUQ committee overseeing new program approvals. **Motion Carried**

At this point, the Vice-Principal resumed the Chair.

ii) Approval of Degrees, Diplomas and Certificates to be awarded at Convocation of June 9, 2007

The Registrar, Mr. Jodoin, presented the list of potential graduates for the Convocation to be held on June 9, 2007. The Deans were asked to indicate cases where the final results of spring courses, courses being taken elsewhere, or supplemental examinations were still outstanding.

It was moved (Beauchamp/Béquet) that Senate receive the candidate for the degree of Master of Arts, as presented by Mr. Jodoin, and that these candidates be recommended to the Business Meeting of Convocation. **Carried**

It was moved (Beauchamp/Sheeran) that Senate receive the list of candidates for the degree of Master of Education, as presented by Mr. Jodoin, and that these candidates be recommended to the Business Meeting of Convocation. **Carried**

Dean of School of Business Béquet raised an issue about the Distinction Mention since current practices vary between divisions and departments. Members wondered how consistency could be achieved in the future. This issue should be addressed by ASAP.
