5/502 COMMITTEE ITEMS

5.1 Senate Planning Committee Report

The Chair of the Senate Planning Committee (SPC), Prof. B. Robson was invited to present the February of Senate Planning Committee report. He reminded Senators that the December SPC report had been approved in principle in December 2007.

It was moved (Beauchamp/Viens) that Senate approve the December Senate Planning Committee report. **Motion Carried**

Discussions resumed on the February report (document 502/5.1). A hiring freeze was discussed; a consensus was reached to leave this issue for Finance Committee. Another topic discussed was the pay scale level at which new professors could be hired.

WHEREAS SPC has reviewed all tenure-stream requests that were presented to this year's 2007-08 SPC (some have been presented to SPC in previous years).

WHEREAS SPC's premises is using the recently Senate-approved parameters to evaluate all requests (no matter when they were first presented to SPC), as those parameters are the best tools to allow Bishop's to reallocate resources where they are most needed. Further, SPC has had to strictly define both new and replacement positions.

WHEREAS the faculty complement of tenure-stream positions is 113. Four faculty members will either retire or resign by the end of this academic year; one will retire in December 09. Faculty complement would be at 108.5 tenure-stream positions in 2008-09 if no tenure-stream positions are filled this coming year.

It was moved (Beauchamp/Martinez) that Senate recommends to Finance Committee the following tenure-stream positions, in order of priority:

- Education (replacement position 8.5)
- Business (replacement position 19)
- Education (NEW position 9.5)
- Biochemistry (NEW position 2.5) & English (NEW position 6.25)
- Business (replacement position 20)
- Psychology (replacement position 7)

Motion Carried

WHEREAS using the Senate-approved formula for allocation of part-time credits, which is calculated on divisional/school student-faculty ratios, divisions/schools would be allocated the following number of part-time credits to replace faculty on regular salary in 08-09 who will either be on sabbatical, on partial retirement, or a dean or on teaching load reductions allowed for under 9.14 of the regular faculty CA.

It was moved (McRae/Martinez) that Senate approve the following Reduced Teaching Load Allocation:

Business: calculated at 70% replacement 42 credits

Education: calculated at 80% replacement 24 credits

Humanities: calculated at 60% replacement 54 credits

Natural Sciences: calculate at 50% replacement 51 credits

Social Sciences: calculated at 70% replacement 52.5 credits

Motion Carried

WHEREAS SPC, in making its recommended allocation, has focused on the CRU-faculty ratio, as the latter demonstrates the high service component that some departments/programs play in the delivery of academic programs. SPC took the approved allocated credits for 2007-08 and applied the 80%-50% replacement scale to those credits in order to achieve savings and responsibly allocate diminished resources.

It was moved (Beauchamp/Martinez) that Senate approve the following Part-Time Credit Allocation:

Business: calculated at 70% levels of 07-08 43.5 credits

Education: calculated at 80% levels of 07-08 66 credits

Humanities: calculated at 70% levels of 07-08 105 credits

Natural Sciences: calculated at 50% levels of 07-08 21 credits

Social Sciences: calculated at 80% levels of 07-08 84 credits

Motion Carried

It was moved (Beauchamp/Rowe) that the Deans of the Divisions and the Chair of the School of Education meet with the SPC to ensure that course offerings for 2008-2009 reflect the direction taken in the December and February reports and support the requirements of inter-divisional programmes. **Motion Carried**

At the end of the discussion, Senate acknowledged the hard work of Senate Planning Committee.

6.1 Library Material Evaluation for New Course Proposals (document 502/6.1)

The University Librarian proposed that a formal procedure for collaboration with the librarians on the development of new courses be adopted by the Departments and the Divisions.

It was moved (Teasdale/Harries) that Senate highly recommends that the academic departments inform librarians as soon as possible when they are developing new courses to determine how the Library can effectively meet the research needs of the students. **Motion Carried**
