#### MINUTES OF THE 503rd MEETING OF SENATE

#### 3/503 COMMUNICATIONS FROM THE CHAIR

The Interim Principal, Dr. Rittenhouse, reported that:

- There was no further update from the MELS.
- Three NSERC awards were given to Bishop's students, the same number as last year.
- Dr. Tom Fletcher is not present tonight because of medical problem. Every member of Senate wished him good news and full recovery.

#### 4/503 BUSINESS ARISING

## 4.1 Grading System

The Dean of the Division of Natural Sciences and Mathematics, Dr. Willms, reported that the Division preferred keeping the present percentage grading system, but was not opposed to a dual system where both percentage and a letter grade would appear on the transcript.

The Dean of the Business School, Prof. Béquet, reported that the issue had not been discussed because there had not been a divisional meeting.

The Dean of the Division of Humanities, Prof. Sheeran, reported that members of the division are not opposed as long as they can mark as they are used to.

The Chair of the School of Education, Dr. Beauchamp, reported that members of the school were positive about moving towards a letter grading system.

Dr. Rittenhouse reported that an NSERC survey indicated that the vast majority of universities use the letter grade system (GPA). The main issue remains about the risk of disadvantaging Bishop's students in Canada when they are compared to other students in national competitions.

It was agreed that ASAP should come up with a resolution for Senate\*.

## **5.1 Senate Planning Committee Report** (document 503/5.1)

It was moved ( Johnson/Sheeran ) that Senate approve the March Senate Planning Committee report. **Motion Carried** 

# **5.2 Senate Teaching Evaluation Committee** (document 503/5.2)

Dr. Faraoni presented a brief report and motion.

WHEREAS Currently, the Senate Teaching Evaluation Committee is required by the Collective Agreement to assess requests for course release ``involving the improvement of teaching skills and performance and/or significant curriculum development" (art. 9.14c.iv of the CA). However, there is no mention of this duty in the mandate of the Senate Teaching Evaluation Committee, which reads:

"The mandate of the Committee include the maintenance of the database generated through the teaching evaluations by students and oversees the creation of a resource center whose purpose would be to improve the overall quality of teaching at Bishop's University."

Dr. Faraoni moved, seconded by Mr. A. Martinez P., that Senate changes the mandate of the Senate Teaching Evaluation Committee to:

(changes in capital)

The mandate of the Committee includes: the maintenance of the database generated through the teaching evaluations by students; OVERSEING the creation of a teaching resource CENTRE whose purpose would be to improve the overall quality of teaching at Bishop's University; AND ASSESSING REQUESTS FOR COURSE RELEASE FOR PROJECTS INVOLVING THE IMPROVEMENT OF TEACHING SKILLS AND PERFORMANCE AND/OR SIGNIFICANT CURRICULUM DEVELOPMENT. **Motion Carried** 

In light of the work the Academic Redeployment Committee, some concerns were voiced about the last sentence in the report about a teaching resource centre.

# **5.3 Report: Committee on Academic Administrative Structures** (document 503/5.3)

Dean A. Johnson assumed the Chair at this point.

Dr. Rittenhouse presented the report and asked Senate to recognize three faculty members, Dr. Seale, Dr. Yeats and Dr. Taseen. The Executive Committee of Corporation has already adopted in principle the report, pending Senate's approval, at its last meeting.

Highlights of the recommended structures are:

 will cost less than the present structure (a minimum of \$100k in savings) and will maintain the basic structure of a Vice-Principal and Deans;

- will ensure that specific functions and mandates within academic administrative structures are assigned to individuals so that the University is confident that critical tasks are being carried out, co-ordinated and evaluated;
- will be a three-year experimental structure (2008-11) so that any further changes might be made to allow continuation of this proposed structure. Aspects of the current academic administrative structure that are not changed will remain in place along with the changes.

It was moved (Faraoni/Bentabet) that the report of the Committee on Academic Administrative Structures be referred to Divisions for discussion.

It was answered that many requests for submissions were sent to individual faculty. After a lengthy discussion, **the motion was defeated.** 

WHEREAS some gaps need to be filled before implementation of the report.

It was moved (Rittenhouse/Wald) that Senate adopt the report of the Committee on Academic Administrative Structures. **Motion Carried** 

#### 6/503 OTHER MATTERS

At this point, Dr. Rittenhouse went back to chairing the meeting.

**6.1 Sessional dates** (document 503/6.1)

The Registrar presented the changes to the Sessional Dates.

WHEREAS Senate approved the 2008-09 Sessional Dates at its January 22, 2008 meting;

WHEREAS the School of Education has decided on the Sessional Dates that apply specifically to the students in their programs;

WHEREAS the Collective Agreement between Bishop's and the Staff states that the Canada Day Holiday will be on June 30, 2008 instead of July 1, 2008 for this year.

It was moved (Sheeran/Béquet) that Senate amends its January 22, 2008 motion to incorporate these changes to the 2008-09 Sessional Dates.

Motion Carried

# **6.2 Campus-wide Paper Waste Reduction Submission** (document 503/6.2)

Senator Martinez P. asked that the students be recognized. A presentation was made of the proposal to reduce paper waste and providing five methods that are conducive to saving paper, and thus trees, highlights are:

- 1. Only assignments which have printing on both sides of each page will be accepted.
- 2. Assignments which are printed on the blank side of used paper, and clearly identified, will be accepted.
- 3. Assignments [whether typed or in power-point or another format], no longer than twenty-five pages, will be accepted on a compact disk (CD), rather than being printed out.
- 4. Assignments will be accepted digitally through electronic mail
- 5. Cover sheets will not be required for any assignments submitted.

It was noted that this proposal is permissive rather than restrictive, thus not affecting any other format requirements or guidelines to which the institution may desire to adhere with.

It was moved (Martinez P./Posie) that Senate supports the Campus-wide Paper Waste Reduction proposal brought by the Sustainable Development Action Group (S.D.A.G.). **Motion Carried** 

## **6.3 Johnville Bog** (document 503/6.3)

Dr. Rittenhouse reported that the City of Sherbrooke wishes to sell the property to Bishop's University and the University of Sherbrooke for \$1. The Johnville Bog is managed by a non-profit organization. A Bishop's professor, Dr. Van Hulst has been a member of the Board of that organization.

# **6.4 Memorandum of Understanding (NSERC) and (SSHRC)** (document 503/6.4)

Dr. Rittenhouse explained that the three research councils require Bishop's to sign a Memorandum of Understanding to continue to receive funding. The Executive Committee has already approved the terms of the Memorandum of Understanding between Bishop's and the federal granting Agencies concerning the roles and responsibilities in the Management of Federal Grants and Awards.

It was moved (Faraoni/Willms) that Senate allows the Interim Principal, Dr. Rittenhouse, to sign the Memorandum of Understanding. **Motion Carried** 

## 6.5 DNS response to Senate requests for opinions (document 503/6.5)

## i) last 30 credits rule

The Dean of the Division of Natural Sciences and Mathematics, Dr. Willms, reported the Division is strongly opposes changing the present rule regarding transfer credit in the last 30 credits of a Bishop's degree program. The present rule works well and is flexible and professors are encourage to exercise sound judgement in disallowing course credit transfers for courses of dubious quality.

The Dean of the Division of Humanities, Prof. Sheeran, reported the members of Division generally felt the rule is sufficiently firm and flexible. Online courses will be looked at more closely to make sure of the quality.

# iii) DNS request

Dean Willms reported the Division of Natural Sciences and Mathematics asks Senate to offer the necessary support to all its new redesigned programs and initiatives, and notes that, as the division with the highest number and proportion of externally funded principal investigators, we are unduly penalized by the new SPC parameters.
