3/508 COMMUNICATIONS FROM THE CHAIR

Mr. M. Goldbloom said he felt warmly welcome by the Bishop's Community. He added that he felt there was very positive energy on campus. He commented on enrolment: total enrolment is down, but the entering class is 13% larger than last year which gives a positive outlook for the future if it continues.

There will be a Special Convocation on October 17, 2008 for the installation of the Principal. Two honorary degrees will be awarded to Dr. Irving Abella and Supreme Court of Canada Justice Mrs. Rosalie Abella will receive honorary degrees.

Finally, Mr. Goldbloom informed Senate about the Quebec Government's will to legislate about university governance.

6.1 Plagiarism (document 508/6.1)

The Registrar presented briefly his 2007-08 academic year report noting a slight increase in reported cases of academic dishonesty.

6.2 Exam schedule 08-09 (document 508/6.2)

Mr. D. Horne explained that given the recent rise of fuel and transportation costs, students from afar are becoming increasingly concerned with booking early flights to receive the best possible rates. A major hurdle for students to book early flights, is a late release date for the exam schedule. Currently there is no explicitly stated release date. Ideally, Students would like to see the exam schedule released before the Thanksgiving break to allow students to coordinate flights with their parents.

It was moved (Horne/Ho) that faculty must submit their exam scheduling forms on or before Sept. 25, so that Records office can have the exam schedule posted before Oct. 10, 2008. In winter semester, forms must be submitted by January 30, so that the Records office can post the exam schedule before February 12, 2009. The previous model for exam scheduling will be applied in future years to ensure that students are informed at the earliest possible time to allow travel scheduling. **Motion Carried**

6.3 Special Meeting of Senate

The Vice-Principal and the Registrar informed Senate that there will be a Special Meeting of Senate before the next regular meeting of Senate. The purpose of the meeting will to recommend the list of graduating students to the Business Meeting of Convocation prior to the Special Fall Convocation.
