### 5.1 Senate Research Committee

(document 517/5.1)
Following the motion passed at Senate on February 23, 2009 about research clusters, Dean S. Harvey reported that the Senate Research Committee (SRC) had completed the first phase of identifying criteria to help recognizing research clusters. Upon adoption of these assumptions by Senate, the SRC will use these to identify and recommend to Senate its major axes of research in fall semester 2009.

It was moved ( Harvey/Childs ) that Senate adopt these research clusters criteria:

1- Builds on existing or developing research and creative scholarship strengths in the faculty (publications, grants).
2- Has potential to attract substantial external funding from granting agencies, as well as other public and private funds.
3- Is poised to help Bishop's benefit from federal, provincial and regional funding opportunities and priorities (e.g., MELS, CFI, etc.).
4- Helps Bishop's demonstrate a regional, provincial, national and international purpose and positioning (e.g., makes a case for our regional contribution and necessity).
5- Has a connection to an identifiable, sustainable theme that is difficult to replicate outside of Bishop's (unique), and/or for which Bishop's has demonstrated strength/niche. 6 - Has the ability or potential to result in peer-reviewed publications (according to the disciplinary standards).
7- Encompasses the work of researchers from more than one discipline, department or division.
8- Relates to strong teaching programs or traditions at Bishop's.
9- Has the potential to include a Canada Research Chair.
10- Demonstrates a record of collaboration or a potential for collaboration with other institutions
11- Contribute to the research opportunities and training for undergraduate students.
12- Makes effective and efficient use of resources available at Bishop's (e.g., does not incur inordinate resources unavailable or difficult to attain).
13- Can lead to or contribute to the development of graduate programs.
