## 5.1 Senate Nominating Committee

### News from Committees

Ms. R. Sheeran indicated that the "Students with Special Needs Committee" will change its name to "Students with Disabilities".

Ms. R. Sheeran also reported that the "Advisory Committee on Writing in English" which hadn't met since 1997, met recently and decided that it should be abolished.

It was moved ( Sheeran/Crooks ) that Senate abolish the Advisory Committee on Writing in English. **Motion Carried** 

# 5.2 Senate Planning Committee (SPC) (document 522/5.2)

Dean. J. Crooks assumed the Chair at this point.

Dr. M. Childs presented in detail the SPC report. Following the Executive Committee's approval of four tenure stream positions, this report deals only with Sessional and Part time allocations for 2009-10 requests. The four tenure stream positions approved were:

- 1. one replacement position in Sociology
- 2. one replacement position in Economics
- 3. one replacement position in Williams School of Business
- 4. one new position in Psychology

The positions which were refused were immediately converted into sessional appointments. In addition, Senate in December approved three sessional appointments in Spanish, Italian and Physics.

In making its recommendations for part-time and sessional budgets, SPC used the part-time allocation parameters for the period 2007-11, with the modifications approved by Senate in October 2009. Because of those modifications, SPC this year divided the reduced teaching load allocation into two main categories: a "firm" category, which included replacements for externally funded research and credits which were absolutely essential to the running of a program (e.g., Sports Studies) and/or were contractual obligations (e.g. APBU relief, replacements for academic officers), and the other categories, such as replacements for sabbaticals, partial retirement, or those on reduced teaching due to departmental administration.

SPC has used the CRU-faculty ratio in making the allocation of regular part time credits, as this better takes into consideration the service function of various programmes. There has been little substantive change in these ratios compared to the previous two years.

Finally, Dr. M. Childs indicated SPC has also reserved a very small number of part time credits for emergency allocation and moved two motions.

Before voting on the motions, Senators discussed at length concerns about the reduced teaching load allocations and part-time credits allocation. Dean J. Crooks said unequal funding across divisions gives the impression that Arts & Science matters less as the University moves forward, that there's a contradiction in asking departments struggling to maintain their core programs, even the place of their discipline in the university, to add more programs, that the unmistakable message sent to the members of underfunded departments is that they should think twice about University service and that the funding formula itself, based on the abstract administrative principle of divisions, discriminates against a number of Arts & Science programs that are very successful by any numerical calculation.

### **Reduced Teaching Load Allocations Motion**

It was moved (Childs/Faria) that Senate approve the following Reduced Teaching Load Allocations:

• General pool (APBU, EC, etc.): 13.5 courses

• Williams School of Business: 5 firm + 9 calculated @ 80% 12 courses

School of Education: 5 firm + 3 calculated @ 80%
 7 courses

• Div of Social Sciences: 5 firm + 24 calculated @ 70% 22 courses

• Div of Humanities: 18 firm + 20 calculated @ 50% 28 courses

Div of Natural Sciences: 7 firm + 24 calculated @ 50%
 19 courses
