### 6.1 Academic Administrative Structures Committee Report

 (document 525/6.1)Dr. M. Childs reported on the highlights of the Academic Administrative Structures Committee Report. He said the Committee was consulting Senate on its report. Faculty members of the Academic Administrative Structures Committee were present at Senate and invited to answer questions.

Senators commented at length the report. The main issues and concerns discussed were:

- The possible appointment of a Dean who might be an external candidate.
- Deans should provided a link between faculty and administration. Should Deans be elected as usual or, selected as the report proposes? The main concern discussed was a greater possibility of a disconnect between faculty members with a Dean who is selected, rather than elected.
- Should Deans have their teaching load reduced to one course or no course?
- Would keeping five divisions with five Deans better serve the students?

### 5.1 Students with Disabilities (document 525/5.1)

Prof. L. McRae presented a document called the "Policy Regarding Students with Disabilities". The purpose of this policy is to clarify the rights and responsibilities of Bishop's University, its staff and students with respect to academic accommodations for students with disabilities. The office has been renamed "Students with Disabilities Office" (SDO). A full-time person has been hired for this office.

### 5.2 SPARC Liberal Arts report (documents 525/5.2a, 2b, 2c)

Dr. Childs presented the external Report of the Program Review Committee of the Liberal Arts program. Senate received the report.

Dr. Childs presented a motion on the SPARC schedule for 2010-11. With the planned renovations of the science labs during the 2010 Summer, he indicated that the SPARC review of Biology, and Environmental Studies and Geography would have to be delayed to 2011.

The full time Collective Agreement is explicit that temporary appointments can in no case extend past three years.

It was moved ( Childs/Hull ) that Senate endorse the conversion of the current, continuing sessional position in Physics into a tenure stream position and that this position be offered to its incumbent. Motion carried
