# MINUTES OF THE 539TH MEETING OF THE SENATE OF BISHOP'S UNIVERSITY

The 539th meeting of Senate took place on Monday, November 21st, 2011, at 7:00 p.m., in McGreer 100.

The Vice-Principal Academic opened the meeting, explaining that the Principal would be detained for a few minutes.

#### ITEM 539/1: APPROVAL OF AGENDA

Dale Miner moved approval of the agenda; Steve Harvey seconded the motion.

The Agenda was adopted as circulated.

#### ITEM 539/2 APPROVAL OF MINUTES OF THE 538<sup>TH</sup> MEETING OF SENATE

Dale Miner moved approval of the minutes of the 538<sup>th</sup> meeting of Senate; Trevor Gulliver seconded the motion.

Dr. Gulliver asked that the minutes be modified so as to make it clear that there may still be some room for growth in registration in the School of Education, and

that the Master's degree in Teaching is one of the additional profiles that would trigger need for more resources in the School.

# ITEM 539/5 COMMITTEE REPORTS

# 5.1 Report of Senate Planning Committee

Senate received the Report of Senate Planning Committee regarding changes to programs and courses recommended by Departments and programs. All of the changes recommended had been approved at the Departmental and Divisional levels. With the exception of the proposed Liberal Arts Double Major, Senate Planning Committee had approved all changes as proposed.

Following the motion that had been approved by Senate Planning Committee, the Vice-Principal moved that approval of the Liberal Arts double major proposal be contingent on the following changes:

- That the proposed differential entrance requirement be brought to the proper body Admissions Standards and Academic Planning Committee for consideration and decision.
- That, Senate Planning Committee being divided on its merits and its applicability, the proposed name of "College" be reconsidered, either by Senate itself, or by returning the question to the program sponsors and Division.
- That Senate Planning Committee devise a way to fairly and equitably count majors in any program in which double majors are mandatory.

This motion would be dealt with in conjunction with the discussion of the proposed modifications to the Liberal Arts Program to be recommended by the Dean of Arts and Science under item 539/7.2.1.5.

# 7.2.1 Division of Humanities

Dean Benoit-Antoine Bacon recommended course and program changes set out in Document 539/7.2.1 in the Departments of Classics, Drama, Fine Arts, Art History, Liberal Arts, Modern Languages, Music and Religion. The motions carried, subject to the comments and conditions set out below.

Dean Harvey asked whether new resources will be required in order to deliver the proposed course and program changes. Dr. Childs replied that an assessment of resources required is a standard part of a submission for course of program changes. Senate Planning Committee had reviewed the submissions from this perspective, and was satisfied that any requirements for additional resources had been appropriately noted.

#### 7.2.1.1 Classical Studies

Rebecca Harries seconded the motion.

# The motion carried, none opposed, no abstentions.

During the course of discussion, the Registrar suggested that the Minor should be 24 credits rather than 25 because one was for a lab. He also raised an issue regarding the exclusions from Greek 200 and 300, and Latin 200 and 300. The Registrar suggested that the reference to replacement of grades in the final sentence in the description of each of these courses should be deleted on the grounds that a grade in a six-credit course cannot replace a grade in a three-credit course.

# 7.2.1.5 Liberal Arts Program

Benoit-Antoine Bacon moved the approval of the proposed Liberal Arts double major program on the understanding that:

- 1. The approval is contingent on the following changes recommended by Senate Planning Committee:
  - a. That the proposed differential entrance requirement be brought to the Academic Standing and Admissions Policy Committee for consideration and decision;
  - b. That the proposed name of "College" be reconsidered, either by Senate itself, or by returning the question to the program sponsors and Division;
  - c. That Senate Planning Committee devise a way to fairly and equitably count majors in any program in which double majors are mandatory.
- 2. The place of science in the program will be revisited, in consultation with the Division of Natural Sciences. The course description for Liberal Arts 217, "The Scientific Odyssey" will be revised to include the topic of the Scientific Method and make it more balanced.
- 3. The Registrar will review and make recommendations regarding the advanced credits to be awarded on entrance to the program, particularly for students entering from CEGEP.

Rebecca Harries seconded the motion.

# The motion carried, one Senator opposed, and five abstaining.

During the course of discussion, it was also noted that the proposal for a double major formalizes what many strong Humanities students do anyway. Some Senators suggested that the substitution of a science requirement by the proposed Lib Arts 217, "The Scientific Odyssey" be revisited. It was unclear to them that the new course would be as effective as a means to teach students about different ways of looking at the world and solving problems, or to enable them to achieve a basic level of scientific literacy. Bruce Gilbert, Chair of Liberal Arts, was recognized by Senate, and explained that the intention was in fact to

reinforce the Science requirement, and that the course would be team taught, with many guest lecturers.

The Vice-Principal Academic reminded Senators that the Committee reviewing the Liberal Education will recommend that all students achieve a level of quantitative and scientific competency as part of one outcome of a Bishop's education.

It was noted that additional professorial resources would be required to deliver the new program. An additional shared position had been approved by Senate Planning Committee and Senate in October, but funding had not yet been approved by the Board of Governors.

# 7.2.1.6 Modern Languages
