#### ITEM 551/3 COMMUNICATIONS FROM THE CHAIR

#### Admissions process

As of the date of Senate, applications for fall 2013 admission were down 15% year over year, with applications from Ontario accounting for the bulk of the drop. Despite the drop in applications and offers of admission, data indicate that the number of students confirming that they will attend is down only slightly from numbers at the same time last year. If the 'will attends' hold, we will meet enrolment targets for fall 2013.

# Sports and Wellness Centre

Construction of the Sports and Wellness Centre was scheduled to begin on April 25<sup>th</sup>, 2013, with the official groundbreaking to take place at a later date.

# Follow up to Summit on Higher Education.

The various '*chantiers*' that were established following the February Summit on Higher Education are under way. The Chairs of each *chantier* are requesting input from universities and others in accordance with their different timelines, but no details are available as of yet as to what will be proposed.

# 5.1 Report of Senate Program Academic Review Committee / M. Childs

# 5.1.1. Review of the School of Education

The Vice-Principal spoke to Document 551/5.1 the Senate Program Academic Review Committee Report on the review of the School of Education, which took place in the fall of 2012. Though the School of Education is subject to regular

accreditation review by the *Comité d'agrément des programmes de formation à l'enseignement* (CAPFE), the SPARC process remains useful: the scope is broader, in that it addresses issues of program coherence and in that it includes programs like the M.Ed. that are not accredited.

The Vice-Principal reviewed the five main recommendations in relation to the B.A. and B.Sc. double major, B.Ed. and graduate programs, concluding that the report was very positive. The School of Education is strengthening its connection with the rest of the University, and has demonstrated that an interest in innovative pedagogy can position it to make a unique contribution, for example in the teaching and learning initiative.

# 5.1.2 Schedule of Senate Program Academic reviews for 2013-14

The Vice-Principal reported that a number of individual Senate decisions had resulted in an accumulation of five reviews in the fall of 2013. He then brought forward recommendations of the Senate Program Academic Review Committee aimed at spreading out the work.

- The Committee recommended that the review of the History Department be postponed for a year, to the fall of 2014, because four senior members of the Department would be on various types of leaves during 2013-14.
- The Committee further recommended that the Department of Philosophy be reviewed in the fall of 2013 and the Department of Religion in the winter term of 2014.
- The Committee had recommended that the Department of Chemistry be reviewed in the fall of 2013 and the Department of Mathematics in the winter term of 2014.

After some discussion of whether the review of the Department of Chemistry ought to be postponed until Senate had received the recommendations in relation to the Department of Biochemistry, Dr. Childs undertook to bring a final recommendation to the May 15<sup>th</sup> meeting of Senate.

Michael Childs moved the approval of the recommended changes to the schedule, and Katelyn LeClair seconded the motion.

# The motion carried.

The Vice-Principal advised Senate that, reports to Senate are in process following external reviews of the Departments of Biochemistry and of Politics and International Studies, and will be made in the fall of 2013.

# 5.2 Senate Nominating Committee / (Ombudsman selection committee) / G. Gagné

Gilbert Gagné, Chair of the Nominating Committee, moved the appointment of Dr. Andrea Drumheller to the Ombudsman Selection Committee. Daniel Miller seconded the motion.

Michael Childs seconded the motion.
