Appendix 1.4: Faculty Salary Scale as of July 1st, 2025: 3.48% increase over July 1st, 2024.

Appendix 1.5: Faculty Salary Scale as of July 1st, 2026: 3.48% increase over July 1st, 2025.

Appendix 1.6: Faculty Salary Scale as of July 1st, 2027: 3.48% increase over July 1st, 2026.

2. The Corporation and the Association agree to the creation of a parity committee on Academic Workload to consider more equitable structures for organizing, recognizing, and compensating academic workload for teaching, service, and research, scholarly, and creative activity.

These new workload structures shall take account of

- The University's strategic objectives; and
- A realistic costing of workload measures and a recognition of the University's financial constraints.

The committee shall consist of no more than six (6) people, with three (3) to be named by the Corporation and three (3) to be named by the Association. Every effort should be made to ensure broad divisional representation.
