ITEM 605/1.5 MEMORIAL MINUTE - PAUL CHIA-SHIANG LIN

Dr. Mary Rhodes read a memorial minute in honour of Dr. Paul Chia-Shiang Lin, who passed away on October 27, 2019.

Paul Chia-Shiang Lin was a native of Taiwan. He obtained his undergraduate degree from the University of Taiwan and came to Canada for his graduate work. He was awarded an M. Sc. by McMaster University and a Ph. D. by the University of New Brunswick.

Paul came to Bishop's in 1981. At first he had a temporary appointment which later became permanent. He retired in 1999 after 18 years of service in the department of Mathematics. He was a quiet self-contained person who carried out his tasks in a thoughtful, conscientious manner. He was always willing to take his share of administrative duties in the department. As a member of a small Mathematics department he taught courses to a variety of students. These included Calculus for Business students, Advanced Calculus and Differential Equations to Mathematics and Science students, and courses in Real and Complex Analysis to Mathematics students. He approached these different areas in a quiet, patient manner much appreciated by the students.

Meanwhile he found time to continue his research in Functional Analysis, an area of mathematics developed during the twentieth century, combining Analysis and Algebra. His publications cover a variety of areas within the subject. Following his retirement Paul continued his researches.

Paul was a familiar figure walking between his home in Lennoxville and the Campus as long as his health permitted.

This year the initial goal was \$70Kto support student mental health resources. Total donations made on Giving Tuesday were \$144K.
