The Chair called the 604th meeting to order at 2:30 p.m.

ITEM 604/1 APPROVAL OF AGENDA

The Vice-Principal Academic and Research requested that item 5.4 be discussed following item 5.1., with the rest of the agenda remaining unchanged. Dr. Gregory Brophy moved the approval of the modified agenda and Dr. Kerry Hull seconded the motion.

ITEM 604/3 COMMUNICATIONS FROM THE CHAIR

The Chair announced that the University was collecting donations to help students affected by Hurricane Dorian. The University has also established a fund to support students affected by the fire in Lennoxville that destroyed an apartment building in the early morning of September 20, 2019. Many of the residents were Bishop's international students. The efforts to support the students affected by the fire are being co-ordinated by the Red Cross and Bishop's Students' Representative Council. The Chair noted that the students whose lodging and belongings were destroyed in the fire were being housed in on-campus residences.

The Registrar, Mr. Hans Rouleau, said any students affected by the fire, regardless of whether they lived in the burned down building, can contact the Manager of Counselling and Accommodation, Ms. Theresa Gagnon.

The Chair said that the Johnson Labs and Greenhouse opening was well received and extended congratulations to Dr. Kerry Hull for organizing the event. He noted that the first Donald Lecture of 2019-20 would be given by Dr. Charles Taylor on September 26, 2019 and encouraged faculty to attend and to promote the Donald Lectures to their students.

6.1 ACADEMIC REPORT

The Vice-Principal Academic & Research, Dr. Miles Turnbull, presented the Academic Report. He noted that Orientation activities were well supported by faculty and staff and their presence was very appreciated, both by incoming students and by their parents who were reassured to see such a supportive welcome.

Dr. Miles Turnbull presented the restructured Research Office, now called the Office of Research and Graduate Studies. Dr. Julie Frédette continues to fill the position of Research Officer with expanded responsibilities to include Graduate Studies. She was joined by Dr. Samia Mihoub who was hired as Grant Officer in the summer of 2019. The search for a Director for Research and Graduate Studies is underway.

Bishop's University will be co-hosting, with Université de Sherbrooke, the annual ACFAS Congress in May 2020. This event will bring close to 5000 scholars from all over the world for the largest French-language scholarly exchange and networking event. Dr. Turnbull encouraged faculty to participate in the conference and to promote the event to their undergraduate and graduate students.

Senators asked what the benefits and obligations are for the University and Adjunct Professors when Adjunct Status is conferred. Dr. Miles Turnbull explained the main advantage is that adjunct professors can publish under the Bishop's name or apply for grants or other projects as being affiliated to Bishop's. This may also show the government that Bishop's is committed to the Sustainable Agriculture and Food Systems (SAFS) program even though the approval process for minors, majors and honours is still some time from gaining final government approval.

The cost to the University for bestowing Adjunct status is minor. Adjunct professors receive an email address, access to facilities and some administrative support.
