The Chair called the 606th meeting to order at 2:30 p.m.

The Principal welcomed Dr. Bill Robson back to Senate and spoke to some events that occurred since the last Senate meeting.

The Principal noted that although on November 1, 2019 the water had risen to the same level as in the 2014 flood, there had been less damage due to changes made in the intervening period and to the effort of the Buildings and Grounds team.

The Principal congratulated Senator Philippe Gravel for winning the cross-country running race organized on the golf course ski trails on November 9, 2019.

ITEM 606/6 OTHER BUSINESS

6.1 ACADEMIC REPORT

Vice-Principal Academic and Research Miles Turnbull presented the Academic Report. He announced that Dr. Amy Svotelis had been hired as the Director of Research and Graduate Studies to start on January 6, 2020.

Registrar Hans Rouleau and Associate Registrar Student Records Nicole Riley presented the enrolment report, including an updated Full-Time Equivalent (FTE) assessment. While the Fall 2019 target for undergraduate enrolment was not met, the target for graduate enrolment was exceeded. However, the additional graduate enrolment did not make up the difference in the shortfall of undergraduate enrolment. The results were broken down by country of citizenship and specific program enrolment rates were discussed. Senators discussed the need to update the Enrolment Prediction model.

Dr. Turnbull said that the Strategic Framework, approved by the Board on November 8, 2019, includes an objective to develop a Strategic Enrolment Plan.

The Chair of the committee, Mr. Hans Rouleau, said that the University policy to 'Withdraw with Permission' was in need of revision. The last time the policy was updated was in 1995. He presented the following motion as indicated in Document 606/5.2:

To move the last day to withdraw from a course from the 7th week to the 10th week of classes. Students would be required only to get the signature from their Departmental Chairpersons. Students would still be responsible for paying for the course but it would be denoted with the WP notation and be excluded from the calculation of their GPA. Once the student is withdrawn from course – the faculty / instructor of the course will be notified by e-mail.
