### Learning Commons

The Principal invited Senators to attend a consultation on the Learning Common project scheduled for Thursday, November 28<sup>th</sup>, 2013.

## Charte affirmant les valeurs de laïcité ...

Between the October and November meetings of Senate, the Government of Quebec introduced Bill 60, the *Charte affirmant les valeurs de laïcité et de neutralité religieuse de l'État d'égalité entre les femmes et les homes et encadrant les demandes d'accommodement*.

The *Commission des institutions* of the National Assembly would hold hearings on the proposed legislation beginning on January 14<sup>th</sup>, 2014.

The Principal would continue to work with other institutions in Sherbrooke with a view to making a joint submission to the *Commission des institutions*. Failing consensus, the Board had asked the Principal to file a brief on behalf of Bishop's University.

#### Student Recruitment

Early application numbers indicated that Bishop's was regaining some of the ground lost in 2013. As of November 15<sup>th</sup>, 2013 applications for Fall 2014 were up by more than 100 over the same date last year.

Bishop's held an outstanding Open House on November 23<sup>rd</sup>. About 250 people, prospective students and their families, attended the event, and at least 20 members of faculty participated in Open-House activities. The Principal acknowledged the work of the Director of Enrolment Management Scott Duguay and Manager of Recruitment Jackie Belleau in making the Open House a success.

#### Quebec-Vermont Forum on Bio-energies

A Forum on bio-energy issues took place at Bishop's on October 25<sup>th</sup> and 26<sup>th</sup>, 2013, in conjunction with the University of Vermont and the *Université de Sherbrooke*, and with the support of the governments of Vermont and of Quebec. Although the conference was relatively small, attracting about 70 participants, there had been a good turnout on the part of the Vermont government. The goal is for the University of Vermont to host the next such Quebec-Vermont event.

#### **U4** activities

St. Francis Xavier University will host a U4 conference on student leadership on the 24<sup>th</sup> of January. This event will complete the first round of activities, with one event hosted by each of Acadia, Bishop's Mount Allison and St. Francis Xavier.

Bishop's University will host a second edition of *Up for debate* on January 31<sup>st</sup> and February 1<sup>st</sup>, 2014.

A Donald lecture by mental health specialist Dr. David Goldbloom on Friday evening, January 31<sup>st</sup>, 2014, will conclude the third annual Mental Health Week at Bishop's and will kick off the *Up for debate* weekend.

Other *Up for debate* events include a student debating tournament focused primarily on issues raised by the Quebec Charter of values. A series of short talks by faculty and students from the U4 universities on the themes of mental health and wellness will be scheduled for the afternoon of February 1<sup>st</sup>.

Several faculty members from other U4 universities who attended the first Up for debate event indicated that they would return for the 2014 edition.

## Sports Centre Construction Project

The Sports Centre construction project was on time and on budget. Contractors were working to close in the new part of the athletic facility before it snowed so as to be able to work through the winter.

Government funding rules require that a piece of 'public art' be commissioned for major new public buildings. A work by artist Nicolas Baier, inspired by images of collisions among particles in the Large Hadron Collider, had been chosen for the Bishop's Sports Centre.
