#### ITEM 557/3 COMMUNICATIONS FROM THE CHAIR - M. Goldbloom

#### Vice-Principal Academic

The Principal welcomed Vice-Principal Academic Miles Turnbull to Senate.

#### Dean, Williams School of Business

At its January 24<sup>th</sup> meeting, the Board of Governors approved the appointment of a new Dean of Business, Dr. Francine Turmel. Dr. Turmel had served as Dean of Business at the *Université de Sherbrooke*, and had held the positions of Assistant Vice-Rector Research and Vice-Dean for Research of the Faculty of Business.

The Board of Governors also approved the hiring of six faculty members to tenurestream positions.

#### ITEM 557/4 BUSINESS ARISING

## 4.1 Submission to the *Commission des institutions – M. Goldbloom, V. Meikle*

The Bishop's University submission to the *Commission des institutions* on Bill 60, *Charter affirming the values of State secularism and religious neutrality and of equality between women and men, and providing a framework for accommodation requests*, was distributed to Senators for information. As of the date of Senate, no date had been set for Bishop's appearance before the *Commission des institutions*.

#### ITEM 557/5 COMMITTEE ITEMS

# 5.1 Senate Planning Committee Report on Part-time Credits - J. Crooks

The Vice-Principal spoke to Document 557/5.1, the Report of Senate Planning Committee on Part-time credits. Dr. Crooks explained that, in light of budget constraints, the initial goal had been 241.5 part-time credits for Fall 2014 and Winter 2015. Senate Planning Committee had concluded, however, that it would not be possible to meet all departmental requirements with less than 263.5 credits. In order to make it possible to meet requirements within budget constraints, some courses were

'borrowed' from the spring term and some additional funds were provided by the Foundation.

Senate Planning Committee had recommended the following allocation of part-time credits:

General Pool	21.5	
Business	30	
Education	21	
Humanities	93	
Natural Sciences & Mathematics	41	
Social Sciences	57	
Total	263.5	

The Vice-Principal Academic moved approval of the allocation of part-time credits as recommended by Senate Planning Committee. Bruce Gilbert seconded the motion.

#### The motion carried.

During the course of discussion, Dr. Crooks indicated that the Dean of Arts and Science would make a proposal, in consultation with Chairs, for the allocation of credits to the Departments in the Humanities, Natural Sciences and Mathematics, and Social Sciences.

## ITEM 557/6 OTHER MATTERS

# 6.1 Draft Strategic Priorities for Bishop's - M. Goldbloom

The Principal noted that the priorities set out in the draft Strategic Plan circulated to Senators had been the subject of discussion within the Bishop's community for some years.

The Principal had presented the priorities to faculty, staff, the Executive of the Students' Representative Council and managers early in January. The document distributed to Senate included additional information on the means that will be used to measure progress against the objectives set out in the draft Plan.

Feedback during the presentations had been positive. The Secretary General would issue a request to the Bishop's community for additional feedback. Once any feedback received from Senate, the Board and the broader community had been integrated, the Strategic Plan would be brought back to the Board of Governors for approval.

The Principal asked Senators whether there was anything missing from the document, and whether they disagreed with any of the proposed priorities, goals, actions or measures.

There was a consensus that the draft Strategic Plan reflected the priorities of the University, and it was suggested the Departments might usefully develop their own plans.

In response to a question about Goal 4 under Priority 1, it was explained that the intention was to leave open a range of possibilities in relation to the academic administration of research at Bishop's.

It was suggested that the promotion of research on pedagogy be added to Goals 3 and 4 in Priority 1.

There was some discussion of the appropriate size of the University. The theoretical maximum of 2,800 full-time students would require optimising enrolment in every program. In light of the challenges this optimisation presents, 2,500 full-time students might be a more reasonable goal. In order to maintain the quality of the education we offer and limit the size of the University, we will have to do the best we can with what we have, and do what we do well even better.
