The Chair called the 573<sup>rd</sup> meeting of Senate to order at 7:06 pm.

ITEM 573/1 APPROVAL OF AGENDA

The Agenda was approved as circulated.

### ITEM 573/2 APPROVAL OF MINUTES

#### 2.1 Minutes of the 572<sup>nd</sup> meeting of Senate, November 2<sup>nd</sup> 2015

Jean Manore moved adoption of the Minutes of the 572<sup>nd</sup> meeting of Senate subject to a correction to the Financial Challenges section of the Communications from the Chair. The first sentence should have read "Bishop's has <u>budgeted</u> a \$4.5M deficit for 2015-16...". Claude Charpentier seconded the motion.

### ITEM 573/3 COMMUNICATIONS FROM THE CHAIR

#### Attacks in Paris

In response to the terrorist attacks in Paris, the Principal reflected that attacks on freedom anywhere are attacks on freedom everywhere. On Saturday, November 14<sup>th</sup>, the day after the attacks in Paris, some 60 French students at Bishop's attended a dinner at the Principal's residence. On the Sunday, a candlelight vigil was held to express solidarity with France.

#### Donald Lecture - Edward Snowden

The lecture by Edward Snowden had the highest attendance – in Centennial Theatre, Bandeen and on-line – of any Donald Lecture. It was an important moment for the University community to hear from and exchange with someone who has acted on his profound concerns about government surveillance and privacy.

#### Government of Quebec and Financial Challenge

The Principal reported that the Deputy Minister of Education, Madame Sylvie Barcelo, had offered the services of former Assistant Deputy Minister, Madame Hélène Tremblay, to assist with our recovery plan. He undertook to keep the Senate informed of developments.

#### ITEM 573/4 BUSINESS ARISING

#### 4.1 Joint Board-Senate Session

The Principal reported that the President of the A.P.B.U. had expressed concerns about holding a Joint Board-Senate session, on the grounds that it would confuse the governance roles of Senate and of the Board and cause academic decision-making processes to be inappropriately influenced by financial considerations.

He then asked the Secretary-General to report on a consultation she had carried out with her colleagues in other universities. Half of the universities that had responded to her inquiry held some form of Joint Senate-Board meeting to discuss topics of broad interest to the university community. On the basis of this information, the Principal had replied to the President of the A.P.B.U. that he intended to go forward with the meeting, and that he would raise her concerns with Senate.

The Principal then indicated that, as Chair of Senate, he was prepared to entertain a motion that the planned Joint Senate-Board session not be held. No such motion was forthcoming.

#### ITEM 573/5 COMMITTEE ITEMS

5.1 Report of Senate Nominating Committee on graduate student appointments to Senate Committees

Chair of the Senate Nominating Committee Hafid Aggouram moved that Senate approve the appointment of graduate students to two Senate Committees as set out in Document 573/5.1. Item 5.2	Report of Senate Planning Committee on tenure-stream hiring – Miles Turnbull,
	Chair

### *Tenure stream positions*

Vice-Principal Academic Miles Turnbull reported that Senate Planning Committee had examined and discussed the submissions of the Schools, Departments and programs in light of the criteria for setting priorities among requests for faculty positions established in 2007 and amended in 2009.

Dr. Turnbull moved that Senate approve the recommendation of Senate Planning Committee that 11 tenure stream positions be recommended to the Board of Governors for approval for 2016-17, in the order of priority set out below.

- 1 Psychology
- 2 Business (Finance)
- 3 Sports Studies
- 4 Politics and International Studies
- 5 Sociology
- 6 Education (Practicum position)
- 7 Business (Entrepreneurship)
- 8 Education (Interdisciplinary)
- 9 Sports Studies
- 10 Modern Languages (Italian)
- 11 Business (Management)

The motion was seconded by Bruce Gilbert. During the course of discussion, a friendly amendment to the motion was accepted to the effect that approval of position #10, in Modern Languages, was conditional on the approval of moving English Language Studies to Continuing Education, which would be proposed for approval later in the meeting.

Senate Planning Committee further recommended that these positions be considered by the Board of Governors for approval as sessional positions for 2016-17 in the event that they are not approved as tenure-stream positions.

The motion carried, none opposed, one abstention.

### Sessional appointments

#### Department of Études françaises et québécoises

Dr. Turnbull moved that a sessional appointment of 12 months be approved in the Department of *Études françaises et québécoises*. Jean Manore seconded the motion.

#### The motion carried, one opposed, no abstentions.

#### Department of Chemistry

Dr. Turnbull moved that a sessional appointment of at least ten months be approved in the Department of Chemistry. Ananya Srivastava seconded the motion.

#### The motion carried, none opposed, one abstention.

#### *Full-time tenure-stream appointment*

Given the exceptional circumstances surrounding the appointment of Dr. Barker to a half-time tenure-stream appointment in the History Department, Senate Planning Committee recommended that Dr. Barker's position be regularized as a full-time tenure-stream appointment, and that this decision be considered independently of the Board process for considering other tenure-stream requests. Dr. Turnbull moved that Senate approve this recommendation of Senate Planning Committee, and Bruce Gilbert seconded the motion.

#### The motion carried, two opposed, two abstentions.

Jean Manore moved that, in the event that the Board does not approve the conversion of the half-sessional position in History to a full tenure-stream position, Dr. Barker's special half-sessional be continued. Bruce Gilbert seconded the motion.

#### The motion carried, ten in favour, five opposed and three abstentions.

#### ITEM 573/6 OTHER BUSINESS

#### 6.1 Notice, austerity teach-in and demo

Dr. Agourram expressed his concern that the posters about the austerity teach-in and demonstration may have painted a picture of the University that is not accurate, and which may have a negative effect, particularly on the recruitment of students.

Senators expressed concern about possible confusion around the source of the posters, and, in particular, whether they had come from students or from a member of the faculty. There was discussion of the role of faculty in publicising student-led initiatives.

The Vice-Principal Academic reported on his participation in the teach-in, encouraging dialogue that aimed to foster a better understanding of Bishop's financial challenges, and urging that different perspectives be represented in future discussions of this kind.

Dean of Business Francine Turmel moved the following course and program changes, as set out in Document 7.1.

*Credits completed on exchange:* 

• The number of credits earned on exchange that students can have recognised for their concentration is limited to nine.
