The Principal called the 574th meeting of Senate to order at 7:08 p.m.

574/1 Approval of Agenda

Dean Murray asked that two additional items from the Departments of Classics and Drama be added to the Division of Humanities recommendations after Music, Item 7.1.1.7 and Item 7.1.1.8 respectively.

574/2 Approval of Minutes

Francine Turmel moved approval of the Minutes of the 573rd meeting of Senate, November 16th 2015 with the following correction to Item 7.1.4: it should read 341 in the text of the paragraph as well as in the title. Bruno Gnassi seconded the motion.

574/3 Communications from the Chair

The Principal thanked Senators for attending the Joint Board-Senate meeting held on November 27, 2015 and reported that members of the Board had deemed it useful. He urged Senators to provide feedback on the day to the Secretary General.

The Principal acknowledged Dr. Trygve Ugland, and thanked him for taking on the Chair of the Task Force on Sustainability, a critically important process for the University.

Two University Singers performance had taken place in the week before the Senate meeting. One had taken place at Centennial Theatre. The second, at the *Centre Culturel de l'Université de Sherbrooke* with the *Orchestre symphonique de Sherbrooke*, had been described by La Tribune as 'a perfect Christmas concert'.

The Principal reported to Senators that former Assistant Deputy Minister Hélène P. Tremblay would be working with the University to find solutions to our financial challenges.
