The Chair, Dr. Miles Turnbull, called the meeting to order at 7:05

Item 1: Approval of Agenda

The agenda was approved as distributed.

Item 2: Approval of Minutes

Rotterdam International Case Competition Team

The Chair congratulated the four students representing Bishop's at the international competition. The team made the finals and finished in 4^{th} position.

Centraide

Bishop's raised \$14,500 for the Centraide Campaign. Dr. Turnbull acknowledged the efforts of Dean Turmel and Deb Langford.

Item 5: Committee Items

5.1 Report of the Senate Planning Committee

Senior Stream and Sessional Position

Dr. Turnbull presented the recommendation of the Senate Planning Committee for tenure-stream positions.

Motion 1:

The Senate Planning Committee, having examined and discussed the submissions of the various schools, departments and programs under the guidance of the Resource Allocation Policy approved by Senate on September 19, 2016, recommends the the following motion be adopted: That Senate recommend the following tenure stream positions, in order of priority, for approval by the Board of Governors for the 2018-19 budget:

- 1- Sports Studies
- 2- Psychology
- 3- Business
- 4- Politics
- 5- Education

Senators raised questions and concerns that not replacing departing faculty members would negatively impact the quality of education . The Chair explained that leaves do not automatically lead to replacement. A Senator inquired about whether spring and summer courses should be included in the RAM Score. It was noted that the position requested by Sociology had the wrong title.

The motion carried, one abstention, one against

Motion 2:

The following motion was made by Miles Turnbull and seconded by Angie Petitclerc:

Senate Planning Committee recommends that Senate establish an ad-hoc task force to bring creative solutions to the future of language programs at Bishop's. This task force should be established as soon as possible and should report back to Senate by May, 2018. SPC recommends that this task force include the Vice-Principal Academic, the Dean of Arts and Science, one representative from each language group (French, ESL, Spanish, German, Japanese), selected by these members and one member at large.

Considerable discussion ensued, including an impassioned intervention from the Humanities student Senator. The Chair invited Jean Levasseur to share his concerns on behalf of the Étude françaises et québécoises department. Dr. Levasseur opined that Senate should reject the motion. The Senators questioned the task force's composition and expressed concern that the provided document insinuated that the mandate of the task force involved considering the merger of Étude françaises et québécoises and Modern Languages.

After the mover and seconder accepted a friendly amendment to add a representative from the English department to the Task Force, the motion carried with three abstentions.

In order to reflect Senators' support for the work of the Department of Études françaises et québécoises, and at a request from the floor of Senate, Miles Turnbull made the following motion, seconded by Marie-Josée Berger.

Motion 3:

Be it moved that Senate recognises the essential role of French language education at Bishop's University.

Item 5.2: Report of the Senate Program Academic Review Committee

Miles Turnbull presented the report of the Senate Program Academic Review Committee regarding the three departments that were under review in the winterspring of 2017: Sports Studies, Chemistry and Mathematics. Miles Turnbull presented the revised Guidelines for Visiting Scholars. On behalf of the SRC, Miles Turnbull moved adoption of the attached draft of the Guidelines for visiting scholars. Matthew Mulkern seconded the motion.

Miles spoke briefly about the academic report and gave an update on student retention results for fall 2017. Many initiatives have been implemented over the past two years to

increase retention and Bishop's will continue its efforts. Senators requested that Spring and Summer data be included in the analysis.

6.1 Discussion on Study Days

On behalf of the Students' Representative Council and in order to support mental health on campus and encourage academic success, Erica Phillips moved that Senate endorse in principle the concept of adding two fall study days in the 2018-2019 sessional dates, and that the Academic Standing and Admissions Policy Committee return to Senate in December 2017 with a proposal of sessional dates including two study days. Matthew Mulkern seconded the motion.

The motion carried
