The Chair called the meeting to order at 5:35 p.m.

The Chair welcomed Helen Tintpulver, new SRC Humanities Senator.

Item 1: Approval of Agenda

The agenda was approved as distributed.

Item 2: Approval of Minutes

The approval of the minutes of the 591st Meeting of Senate is postponed to the next meeting.

Item 3: Communications from the Chair

The Chair spoke to the success and the quality of the two recent Donald Lecture speakers, Maggie MacDonald and Rick Hansen. The Chair also spoke to the fact that these lectures are institutional priorities and invites people to attend in higher numbers.

Bishop's Debate Team was among the only three teams with perfect scores at the recent Up for Debate weekend, but unfortunately did not make it to the final. The team from St. Francis Xavier won this year's competition.

## Item 4: Business Arising

## 4.1 Change of Senate Time:

The Chair asked the Secretary General to provide background on the decision made regarding the change of time for future meetings of Senate. Ms. Dufour explained that following a survey circulated amongst the Senators, the time period that received the most votes (20 votes out of 25 participants) was 3:30 p.m. to 5:30 p.m. However, considering that students are often not available before 5:00 p.m. due to classes which they chose this year under the understanding that Senate would be in the evening, Ms. Dufour selected the most popular option after 5:00 p.m., which was 5:30 p.m. to 7:30 p.m. (with 18 votes out of 25). The 7:00 p.m. to 9:00 p.m. period was the least preferred time according to the survey (11 votes out of 25 participants).

A general discussion followed about potential scheduling conflicts if the time of the remaining meetings of Senate for 2017-18 were to be changed to 5:30 p.m.

The Chair suggested that a revised survey regarding a potential change to the time of the meetings of Senate for 2018-19 rather than 2017-18 be drafted and distributed.

## Item 5.1: Report of the Senate Planning Committee on Part-time Credits

Dr. Turnbull provided Senate with a detailed PowerPoint presentation of the Senate Planning Committee's decision-making process and recommendations on part-time credits. Dr. Turnbull started by thanking all of the members of the Senate Planning Committee.

In 2017-2018, 235 part-time credits were allocated. For 2018-2019, SPC recommends

- an allocation of 253 credits (see attached detailed spread sheet);
- a 10 month special sessional instructor in Chemistry;
- a 12 month special sessional instructor in *Études françaises et québécoises*.

This year, the Senate Planning Committee requested clarifications or meetings with some Departmental Chairs, when the Committee felt it was required. A Senator requested that the Senate Planning Committee maintain the consultation process.

A general discussion followed about the decision-making process and the contributing factors in the decision-making process.

Should departments or programs request a 12-month sessional, the academic unit would be required to cash in the actual cost of 12-month sessional.

In making this motion, Dr. Turnbull indicated that the Senate Planning Committee would be surprised that academic units would be in a position to sacrifice the number of courses required to support the cost of a 12-month sessional.
